Project implementation took place from June 2020 to April 2021.

Through the Swiss PRO Programme, the Swiss Government supported 13 local governments to establish Citizens' Advisory Services as a systemic and publicly available mechanism aimed at improving access to rights and the position of vulnerable social groups at the local level.

BABUŠNICA	Swiss PRO 15,003 EUR LSG Co-funding - Total Value 15,003 EUR	Lawyer Dimitrije Adamović , followed by Srđan Jovanović and Aleksandar Aleksandrović , provided advisory services within the existing Service Centre in the Municipality building, as well as in five largest local communities. After project completion, the lawyer is still engaged with the Municipal Administration.
BELA PALANKA	Swiss PRO 13,544 EUR LSG Co-funding - Total Value 13,544 EUR	Lawyer Marija Kostić , followed by Miljan Randelović , selected from the National Employment Service unemployment records, provided legal support in the Municipality building, while once a week they worked in the field in one of the largest local communities (Crvena Reka, Divljana, Koritnica, Klisura and Miranovačka Kula).
ČUPRIJA	Swiss PRO 15,641 EUR LSG Co-funding 4,531 EUR Total Value 20,712 EUR	Lawyer Nikola Atanasijević provided legal support both in the Municipality building and in local community offices in villages, according to a pre-defined schedule. After project completion, the lawyer stayed on as employee with the Municipal Administration.
ČAJETINA	Swiss PRO 14,342 EUR LSG Co-funding 996 EUR Total Value 15,338 EUR	Lawyer Aleksandar Bajčetić provided legal support in the Municipality office (with access provided to PWDs), and during field visits to mountain villages.
KNIĆ	Swiss PRO 15,328 EUR LSG Co-funding 1,411 EUR Total Value 16,739 EUR	Lawyer Veljko Stanojević , followed by Milica Radić , provided legal support for two days in the Municipality building and three days in the field in local community offices in Gruža, Toponica and Bare, where there is a large share of socially vulnerable and older population.
KRUPANJ	Swiss PRO 16,081 EUR LSG Co-funding - Total Value 16,081 EUR	Lawyer Marijana Kostadinović , followed by Tanja Todorović , worked full time, while two days per week they provided advisory support in the field in one of the 24 local community offices. Excellent co-operation was established with other local institutions, especially the Centre for Social Work. After project completion, the lawyer stayed on as employee with the Municipal Administration.
MALO CRNIĆE	Swiss PRO 14,500 EUR LSG Co-funding - Total Value 14,500 EUR	Lawyer Maja Arsić provided full-time legal support in the Municipality office, with a pre-defined work schedule in the field.
MEDVEĐA	Swiss PRO 13,393 EUR LSG Co-funding 869 EUR Total Value 14,262 EUR	Lawyer Stefan Stošić provided advisory services in local community offices (in Lec, Tular, Sijarinska Banja and Ravna Banja) twice a month, and on other working days in the premises of the local self-government. After project completion, the lawyer is still engaged with the Municipal Administration.

RAČA	Swiss PRO 16,724 EUR LSG Co-funding - Total Value 16,724 EUR	Lawyer Snežana Miljković provided advisory services in the Municipality building, and in rural local communities that are over 20 km away from the municipality administrative centre and inhabited by vulnerable groups unable to reach the centre. After project completion, the lawyer is still engaged with the Municipal Administration.
SVILAJNAC	Swiss PRO 16,351 EUR LSG Co-funding - Total Value 16,351 EUR	Lawyer Marijana Milošević , followed by Dušan Radević and finally Dragana Stojanović , provided advisory services in the Municipality building, and once a week in different local communities. After project completion, the lawyer is still engaged with the Municipal Administration.
SJENICA	Swiss PRO 13,393 EUR LSG Co-funding - Total Value 13,393 EUR	Lawyer Mersiha Hamidović provided full-time advisory services not only in the Municipality office, but also in local communities, since the villages are dispersed, and most people are over 65 years old, members of socially vulnerable groups.
SURDULICA	Swiss PRO 15,965 EUR LSG Co-funding - Total Value 15,965 EUR	Lawyer Ivana Radulović provided full-time advisory services in the Municipality office, as well as in local community offices. Field work was co-ordinated with the Mobile Team for Social Inclusion of Roma and the provider of home assistance service for older people. After project completion, the lawyer is still engaged with the Municipal Administration.
ŽAGUBICA	Swiss PRO 16,742 EUR LSG Co-funding 11,863 EUR Total Value 28,605 EUR	Lawyer Dragan Stojanović provided legal support in the Municipality office for two workdays and the remaining three workdays in the villages Krepoljin, Laznica and Osanica. After project completion, the lawyer is still engaged with the Municipal Administration.
